## 2. Year in Review

2.1. The appointment of a new treasurer has proven to be invaluable. Riana hit the "ground running" and very quickly got a handle on the finances.

2.2. A summary of the important work we will carry on doing and improve will be:

2.2.1. The utilisation of the Managing Agent's technology platform to build an updated database of homeowner records, the regular e-mail and telephone communications between the Managing Agent and homeowners, the sending of electronic invoices, statements and other required or useful notices;

2.2.2. The Managing Agent and trustees have done a fantastic job in collecting outstanding levies, and the total outstanding debt continues to reduce monthly. The trustees and I would like to thank those homeowners that paid their levies timeously.

2.2.3. The trustees have engaged the services of a debt collection agency to ensure the recovery of all levies due to the HOA. The financial stability of the Association depends on it!

2.2.4. The Managing Agent has received several complaints about barking dogs. Residents are reminded to be considerate towards their neighbours and the community.

2.3. The rejuvenation of our local parks:

2.3.1. The appointment of a new garden services contractor has resulted in reduced spending on maintenance of our parks. Our parks continue to look neat and are a credit to our neighbourhood. There has been a noticeable increase in Homeowners using these amenities.

2.3.2. Trustee Kobus van Eyk has taken the parks under his wing and the improved condition of the parks is largely due to his efforts to ensure the City of Cape Town upholds their commitment to maintaining our parks. Kobus has spent many hours and phone calls to ensure our parks remain neat and tidy. Special thanks to Kobus for his efforts.

2.4. All of the work done and changes implemented in and around our estate is as a result of the dedicated and hard-working Committee.

## 3. The Year Ahead
